Kindly be advised that your application for the placement of **advertising sign** will be approved subject to the following conditions:

1. That the billboard/s will be located at the following area as indicated above
2. That Despite the other provisions of any regulation, no advertisement may –
 - (i) constitute a danger to persons or property;
 - (ii) be so placed as to distract, or contain an element which distracts, the attention of vehicles in a manner likely to lead to unsafe driving conditions;
 - (iii) be illuminated to the extent that it causes discomfort to or inhibits the vision of approaching pedestrians or drivers of vehicles;
 - (iv) be attached to traffic signs, combined with traffic signs (unless specifically authorised by the National Road Traffic Act), obscure traffic signs, create confusion with traffic signs, interfere with function of traffic signs or create road safety hazards;
 - (v) obscure the view of pedestrians or drivers or obscure road or rail vehicle and road or sidewalk features such as junctions, bends and changes in width;
 - (vi) Project over pedestrians or cycle circulation routes, unless the clear height of the advertisement exceeds 2,4 metres;
 - (vii) obstruct fire escapes or the means of egress to fire escapes;
 - (viii) be placed closer than the minimum clearance with regard to overhead power lines as prescribed by any law;
 - (ix) be erected in the vicinity of a signalised intersections which displays the colours red, yellow or green if such colours will constitute a road safety hazard;
 - (x) have light sources that are visible to vehicles travelling in their direction;
 - (xi) be erected without approval where such approval is required by the Act, municipal by-laws or any other law;
3. No outdoor advertising signs shall be permitted on overhead bridges or pertaining walls adjacent to a road safety measure;
4. The following charge payable in respect of each application for outdoor advertisement signs or hoardings shall be paid in advance on the submission of the application or before the application can be approved:
 - (i) An application fee of **R497.17***once-off* is payable
 - (ii) Rent tariff (subject to increase) **R64.02** *per m² per month* and is yearly payable in advance.
5. The billboard/s permit is valid for a period of twelve (12) months i.e.
6. The owner of the sign accepts full public liability with respect to any claim which may arise from the sign and indemnifies the Maruleng Local Municipality of any claim whatsoever that may come forth directly from the existence of signs.
