## PUBLIC NOTICE CALLING FOR INSPECTION OF THE 2<sup>ND</sup> SUPPLEMENTARY VALUATION ROLL FOR 2023/2024

Notice is hereby given in terms of Section 49(1) (a) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the 2<sup>nd</sup> Supplementary Valuation Roll for the financial year 2023/2024 in terms of Section 78 of the Act is open for public inspection at the **Municipal Library**, **64 Springbok Street**, **Hoedspruit**, **1380**, during normal office hours (08H00 to 16H00) or on Municipal Website (www.maruleng.gov.za) for a period of 30 days starting from the 16<sup>th</sup> May 2024 until the 28<sup>th</sup> June 2024.

An invitation is hereby made in terms of Section 50 (1) of the Act that any owner of property (indicated below) or other person who so desires should lodge an objection on the official prescribed application form with the Municipal Manager in respect of any matter reflected in, or omitted from the 2<sup>nd</sup> Supplementary Valuation Roll 2023/2024 within the abovementioned period.

Attention is specifically drawn to the fact that an objection must be in relation to a specific individual property and not against the valuation as such. The form for the lodging of an objection is obtainable at the Municipal Library at 64 Springbok Street, Hoedspruit, 1380 or on Municipal Website (<a href="www.maruleng.gov.za">www.maruleng.gov.za</a>). The completed and signed form must be put in a sealed envelope marked "2nd Supplementary Valuation Roll 2023/2024," and be posted to The Municipal Manager, P.O. Box 627, Hoedspruit, 1380 or hand delivered to the address indicated above for the attention of The Municipal Manager. No e-mailed Objections will be accepted.
