TERMS OF REFERENCE/ SPECIFICATIONS

DESCRIPTION: FUMIGATION OF MUNCIPAL BUILDINGS

Discussion

We are experiencing mosquitoes, Flies, ants, coach roaches, snakes, mosquitoes and rodents in the offices. As mandated by the Act it is imperative for the municipality as impelled to eradicate rodents and vectors in the buildings. We therefore request procurement fumigation of mosquitoes, ants, bats and snake repellents for K2C Offices, Calais community Hall, Sedawa Community Hall, Lorraine Community Hall, Moshate Community Hall, Bochabelo Community Hall, Hlohlokwe Community Hall, Makgaung Community Hall, Turkey Community Hall, Enable Community Hall, The Oaks Community Hall, Metz Library and Metz Community Hall. The overall sizes of all the buildings are 6 823 square meters.

Legislation

HBA Regulation 24 of the OHS Act 85 of 1993, fumigation should be conducted quarterly to avoid and/or reduce exposure to Hazardous Biological Agents.

At the end of a fumigation service, the preferred service provider will be required to issue a fumigation certificate or a detailed service report confirming the successful aeration of the treated area and the safe removal of the fumigant. This document typically includes information on the treated location, the fumigant used, gas readings, the date and time of completion, and any recommendations for maintaining a pest-free environment.

Service providers are expected to submit an itemized quote and submit with your bid document (RFQ)

2. **DEFINITIONS**

(a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.

- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "The Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
