The training provider must be able to deliver learning in respect of the following:

- CPR
- AED
- Respiratory distress including artificial respiration
- Chocking blocked airways
- Circulatory Shock
- Wound & Bleeding
- Burns & Fractures

- (e) "The Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
