TERMS OF REFERENCE FOR REFRESSHDER COURSE FOR HOUSEKEEPERS

1. TERMS OF REFERENCE

The municipality would like to appoint a capable service provider to develop the training material and train its Cleaning staff. The training to be offered does not have to be accredited as there will be no assessment conducted. The training material must serve as a refresher course to the employees and must cover the following areas:

- 1. An employee's legal rights;
- 2. Employer roles and responsibilities;
- 3. Employees roles and responsibilities;
- 4. Role of organized labour;
- 5. Employer- Employee relationships;
- 6. Concepts related to the performance of work;

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
